

CUBANISIMO *Vineyards*

RENTAL POLICY

- Capacity: Outdoors: 200 max; Indoor: 40 max.
- Rates & Fees: \$150 per hour. The rate will be applied to setup and takedown. Clean up fee: \$75. Minimum of 2 hours required.
- Deposit: \$300 deposit required at time of reservation. Reservations are only finalized upon the receipt of the deposit along with a signed agreement.
- Refunds: Full refunds are granted if notification is given at least 30 days prior to the event. 50% refunds if notification given within 30 days of the event.
- Amenities: Cubanísimo Vineyards has tables and chairs for up to 40 people inside or 50+ people outside.
- Option 1: Tables & chairs other than those existing at the facility are to be provided and removed by the Rental Party.
- Option 2: Tables & chairs other than those existing at the facility can be provided by Cubanísimo Vineyards at a rate of \$5 per person.
- Seating arrangements must be agreed upon by Cubanísimo Vineyards and the Rental Party at least 14 days prior to the event.
- Catering: Catering to be provided by Rental Party. Catering party is expected to take everything they brought with them when they leave. Equipment for catering includes access to a sink, refrigerator, a water hose, an oven and electrical outlets. Plates & utensils to be supplied by Rental Party.
- Beverages: All beverages are to be provided & served by Cubanísimo Vineyards. No outside alcohol is permitted. There is a minimum purchase requirement of 2 cases of Cubanísimo Vineyards wine. Rental Party must notify Cubanísimo Vineyards of specific requests at least 4 weeks prior to the event. Alcoholic beverages are limited to beer & wine.
- Final Payment: Due at end of reservation period. Final amount due will include remaining rental fee, beverage services, table & chair rental fees, and clean-up fees if applicable.
- Liability: Rental Party must provide a Certificate of Liability Insurance listing Maurice Collada Jr. & Cubanísimo Vineyards Inc. as Certificate Holders on the day of the event. This can be provided by your Home Owners Insurance Agent. Rental Party will be liable for any damage to facilities and equipment that occurs as a result of the event.
- Parking: If Rental Party expects over 50 guests, parking attendants must be present during the arrival period. Parking attendants must be provided by the Rental Party.
